On behalf of the executive committee, we wish you a very peaceful and grace-filled season of Lent.

Last month's luncheon presentation by Ned Doleisi was excellent. He gave us very valuable insight into how the California Catholic Conference (CCC) operates and the challenge it faces in advocating the Catholic Church's public and social policies to the legislative, administrative and judicial branches of the state government. One topic that left a big impression was Ned's discussion of how the CCC frames certain employment and education issues as issues of religious liberty and his explanation of the evisceration of the concept of "conscience clauses" in certain legislation. The presentation was extremely informative and very enjoyable.

Our next luncheon is on Thursday, March 16, 2006, with Mr. Jeffrey Lena, who will speak to us on institutional Catholicism and foreign law. Mr. Lena is an attorney that has represented both The Holy See and the Holy Father in actions in the United States. He is also an expert in foreign law and the law of The Holy See. Mr. Lena will discuss the legal and political relations between The Holy See and American Dioceses, with an overlap on some foreign law. We are very fortunate that he is able to join us in March. So mark your calendars for Thursday, March 16, 2006. The luncheon begins at noon and is in our regular location at the Carnelian Room, 555 California Street, San Francisco.

As you know, we are always interested in enhancing our membership base and collegial spirit. He will speak to us about the California Missions as well as his involvement in the canonization of Fr. Junipero Serra. Lunch will be on Thursday, April 20, 2006.
