In this celebration of the sacramental life of the Archdiocese, the Holy Oils will be marked for use in the sacramental celebrations throughout the coming year. The formal invitation is attached.

### 2014 Dues and Membership

#### Updates from our Chaplain, MSGR Labib Kobti

Pope Francis elevated 19 new bishops to become cardinals on Sunday Feb. 23rd. Some of them are from new countries and the poorest countries like Haiti, Burkina Faso and Ivory Cost. He did not choose any new American cardinals.

In February, the Pope met with the "group of eight" cardinals, representing every continent to hear recommendations to help him govern of the church. The issues discussed include: a) Reform the Vatican Bank and finances and bring accounting up to international standards; b) October Synod of bishops on family issues; and c) prevention of child abuse.

When he could use a Vatican diplomatic passport, Pope Francis, opted out of receiving any privileges in choosing to renew his Argentinean passport and paid for it and for his identity card.

Pope Francis establish the first ever Vatican secretariat for economic affairs, independent of the State Secretariat. It will supervise the financial affairs of all Vatican departments. It will be supervised by another new body, the Council for the Economy, which will include 15 members, eight bishops and seven lay experts, drawn from different parts of the world. Cardinal George Pell of Sydney, Australia, to be the 1st prefect of the Secretariat for the Economy.

#### Challenges:

The Pope will visit Jordan, Palestine and Israel from May 24-26. He will take a helicopter from Jordan directly to Bethlehem which means that he will go to Palestine first before he goes to Israel, as Bethlehem is under the Palestinian authority. The Israelis criticized this move, but the Pope insisted. This is the first time that a Pope has made such a move.

The Pope took the initiative of an unusual step of commissioning surveys from bishops' conferences around the world, congregations and groups on how their peoples understand the Catholic teaching on marriage, sex, homosexuality, birth control, living together, divorce and other issues related of family. Answers that came from some European, USA and Asian Conferences were eye openers: People are mainly unaware, ignore, or and reject as unrealistic the Church's teaching on sexual morals, prohibiting artificial contraception, birth control, condom, living together, civil marriage, divorce and homosexuality. They speak about a "big gap between the Vatican and reality". What would be the answer of the Fathers of the Church at the October's 2014 Synod of Bishop? We are facing difficult times. Prayers are needed.

I followed the UN report condemning the Vatican. It was detailed in many News agencies on TV and in newspapers, but many ignored the response of the Vatican. It was not reported or when reported it was brief and distorted. On French TV they reported the condemnation but they did not say anything about the answer of the Vatican. Did any of

you feel the same? Catholic SF had a good article about the response of the Vatican. It is worth a read.

Will be there a lot of media coverage on the move of the Pope going directly from Jordan to Bethlehem which is under the Palestinian Authority rather than going to Israel and then to Palestine? We will see!

#### Local News:

Archbishop Cordileone announced the appointment of a new permanent President/Rector of St. Patrick's Seminary & University: Rev. Gladstone "Bud" Stevens, S.S., a wonderful Sulpician theologian who is well known to many of you. Currently the Vice Rector, Fr. Stevens will assume his new position on June 1st. He will replace Bishop Tom Daly, assistant bishop of San Jose.

Expect soon the date of the blessing of the Holy Oils at the Cathedral. (Please see the attached invitation from Archbishop Cordileone to Society members to attend the Chrism Mass.)

Ordination of new deacons on May 31st at 11:00 AM (three of them from St. Thomas More Church).
