To that end, we have partnered with the Bar Association of San Francisco and its Housing Negotiation Project to arrange an exclusive CLE class for our members. Attendees will learn how to represent disadvantaged tenants facing eviction at mandatory settlement conferences in San Francisco Superior Court. For these tenants, the settlement conference is often their last chance to avoid eviction and homelessness. Most of those represented by a lawyer succeed in doing so. Those without, sadly, do not.

The class will take place on **Friday**, **August 24 from noon until 2:00 p.m**. at the BASF Conference Center at 301 Battery Street. After completing the class, BASF will coordinate assigning participants to particular cases.

CLOSING THOUGHTS

I was glad to receive positive feedback about the prayers included in the last couple of newsletters. In looking for one this month, I came across something slightly different that I thought well worth sharing:

May 1, 1517 in London became known as "Evil May Day" due to a series of riots that erupted there in a backlash against French immigrants. As undersheriff of London at the time, Sir Thomas More was sent to quell the mob, which he did (temporarily, at least) by delivering a speech from horseback.

That speech was later reimagined and immortalized by none other than William Shakespeare, in his contribution to the play "Sir Thomas More". The play itself was banned by Elizabethan censors, but a manuscript survives and contains the only known example of Shakespeare's handwriting in existence today.
