Toys for Tots

For the first time, we are also hosting a Toys for Tots drive in partnership with the San Francisco Fire Department. The San Francisco Firefighters Toy Program is the largest holiday toy program in San Francisco and the nation's oldest program of its kind. Today, more than 300 firefighters and friends volunteer their time to distribute toys to more than 40,000 disadvantaged children. The Toy Program also serves many other community organizations, including shelters for abused women and children, inner-city schools, children's cancer wards, and pediatric AIDS units.

Monetary and toy donations through the program are tax deductible. Toy donations must be unwrapped and new and intended for children up through age 12. You can bring and place all toy donations in the donation bin at our Christmas luncheon.
