## **Recommended Sources**

Each newsletter, I will attempt to offer some resources for the Society to explore. In addition to Pope Francis' new book referenced above, this month, I recommend Mark Thibodeaux, SJ's book, Reimagining The Ignatian Examen. Some of you may already know the benefits of the Examen as a daily prayer from St. Ignatius, and I encourage others to learn about it for the first time. Take a moment to put down your phones and computers, and consider the prayer as a daily exercise. Thibodeaux reduces the daily Examen to the following 5 Steps, as a Mnemonic device:

- **R**elish the moments that went well and all of the gifts I have today.
- **R**equest the Spirit to lead me through my review of the day.
- **R**eview the day.
- **R**epent of any mistakes or failures.
- **R**esolve, in concrete ways, to live tomorrow well.
