#### Service Project with De Marillac Academy

volunteered collectively to teach a class for De Marillac's Enrichment Program. In all, we put on eight sessions for the class on subjects that ran the gamut of legal practice from criminal and civil litigation in state and federal courts to discussions of practical and philosophical aspects of the law. The students were treated to visits of at the San Francisco Community Court in the Tenderloin, the California Attorney General's Office, and the First District Court of Appeals. A very big thank you to all of our members and friends who participated in the project over the course of the semester and helped to make it a success.

A very, very special thank you goes out to our liaison member, Tony Phillips, who worked closely with De Marillac and all of our volunteers and made sure that everything worked each and every week without a hitch. This project required a large commitment of time beginning before the start of the semester, and it could not have been done without Tony's energy and dedication.
