Dear Colleagues,

Last month we were extremely fortunate to have Mr. Andrew Galvan—San Francisco historian and curator of Mission San Francisco de Asis, or more commonly known as Mission Dolores, speak to us about the California Missions, Native Americans in the Bay Are and the canonization process of Father Junipero Serra. It was an exceptionally articulate address from which we gained very valuable insight into the cultural and historical importance of the California Missions and Fr. Serra's role with the Missions and Native Americans. Mr. Galvan's presentation was captivating, extremely interesting and very enjoyable. He really did enhance our perspective and understanding of the California Missions. For anyone who missed the luncheon I would highly recommend taking Mr. Galvan's tour of Mission Dolores; and then to everyone, I recommend reading A Time of Little Choice by Randall Milliken which describes the independent Native American nations that lived in the San Francisco Bay Area between 1769-1810, their reaction to Spanish influence, and their choices when confronted with the mission system.

As you know, Catholic education and the witness of faith in daily practice were two extremely important tenets of our patron St. Thomas More. As a Society we also want to promote these tenets as well as the importance of community service. Therefore, at our May luncheon we will have a presentation to us by Next Step Learning Center, an innovative adult and family literacy program that serves residents of Oakland. Next Step Learning Center is a California nonprofit corporation founded in 1994 by the Sisters of the Holy Names. The first Holy Names Sisters came to the Bay Area in 1868 to establish schools in California in response to a request from Archbishop Alemany of San Francisco. Their organization is a fantastic community based program that addresses the critical problem of illiteracy in our community and teaches basic literacy, pre-GED and GED preparation as tools of reading, writing, and computation needed for urban life in the 21st Century. One of the Center's two Co-Directors, Sr. Cynthia Canning SNJM, and a recent graduate of the program who is now attending community college, will speak to us about the Next Step Learning Center organization.

So mark your calendars for our luncheon on <u>Thursday</u>, <u>May 18</u>. The luncheon begins at noon and is in our regular location at the Carnelian Room, 52nd Floor, 555 California Street, San Francisco.
